Article 5, added - clause 5.08:

Notice of any meeting or hearing of the Board for the purpose of determining whether disciplinary action should be taken against any member shall be delivered to such member not less than seven (7) days before the meeting or hearing is to take place or shall be mailed to such member by registered post to his last known post office address not less than ten (10) days before the meeting or hearing is to take place, and such member is entitled to be present and make representations at such meeting or hearing.

Article 16, amended - clause 16.02:

Bylaw amendments to be sanctioned by the membership shall be made public on the Corporation's website at least 30 days prior to the date of the Annual Membership Meeting and hard copies will be made available prior to the start of the Annual Membership Meeting to those members in attendance.
